3. No Loan Certificate.
4. State Subject Certificate.
5. Dependent Certificate issued by the Competent authority.
6. All other relevant documents as required under SRO-43.

The appointee shall be on probation for a period of two (02) years.

If, on verification, the certificate(s) produced by the appointee prove fake or forged, the appointment shall be cancelled, ab-initio.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police and CID to whom a reference shall be made by the Chief Horticulture Officer, Baramulla.
