The accord of Administrative Approval is subject to the following conditions:-

- That the proposal is strictly devised and designed as per the latest relevant I.S Code and specifications of PWD/CPWD & other relevant rules, procedures and guidelines are strictly followed during execution of works.
- That the structural design of project is got authenticated by competent authority well before the execution of work and while designing, latest HFL is also taken into consideration for flood prone locations.
- That the building plan and other relevant drawings of the project shall be authenticated by the Competent Authority well before the commencement iii.
- iv. That there is no time or cost overrun involved in the project and set timeline is strictly adhered to. No escalation shall be admissible under any
- v. That the rates for the items, not covered in JKSSR or any other relevant scheduled, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by competent authority well before invitation of tenders in accordance with set codal procedures.
- That the NOC from all Regulatory Authority are sought before the vi. commencement of work.
- That before tendering process, the items related to the quantity of earthworks shall conform to the authenticated NSLs, design Cross sections vii. and L-sections. Moreover pavement Design shall be based on CBR test
- That the Electrical/Mechanical Components are checked and authenticated by the Competent Authorities before invitation of tenders in accordance viii. with the set codal procedures.
- That any such items not covered under relevant schedule of rates shall be paid in accordance with set codal procedures. ix.

That encumbrance free land is available for the execution of the project.

That the Lump sum provisions, either in terms of percentage or fixed as made for certain components are provisional and shall be subject to detailed estimates of cost based on actual measurements, requirements and relevant rates on the basis of specified specifications and make to be framed and approved by Competent Authorities before invitation of tenders in accordance with set Codal procedures.

That e-tendering mode is followed for fixation of award of contract for xii. execution of the project and working DPR is followed in the formation of BOQ for e-tendering purpose of the project. Fragmentation of the project,

while tendering, is not allowed.

That proper rate analysis and market survey has been conducted in light of standing rules and procedures in case of all the items proposed to be executed on ground, prior to issuance of formal NIT for the project, in order to ensure rationality of rates.

The Department shall ensure the use of LED Lamps for all new xiv. connection/loads for Government building/ Institutions/ PSUs/ Industrial

and Commercial establishment and autonomous bodies.

Administrative approval shall be subject to release of funds from the XV. concerned authority

The physical/financial achievements shall be submitted to the

Administrative Department well before the set timeline.

That the actual construction shall be taken up only after accord of technical xvii. sanction by the competent authority.
