 - 6. Relevant Category certificate.
 - 7. Any other relevant documents, if required;
 - (iv) the appointee shall be governed in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S. O. No. 192 of 2020 dated 17.06.2020;
 - (v) if by any chance candidate who is not eligible for the post manages to secure selection by way of misrepresentation and false information and it comes to notice at a later stage, he/she will be liable for cancellation of selection and criminal prosecution as well in light of the Judgment rendered by the Hon'ble Supreme Court;
 - (vi) the inter-se seniority of the appointees shall be as per the merit as it exists in the selection list prepared by the J&K Services Selection Board;
 - (vii) the appointment shall be subject to outcome of the writ petition /OA, if any pending in any competent court/Tribunal;

- (viii) the cadres/departments allocated by appointing authority /SSB shall not be changed under any circumstances by any authority/Department.
- (ix) the appointments shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution;
