ii) Further, the above arrangement:

- a) shall be purely temporary for a period of six months only to look after the work of respective posts till these posts are filled up, under rules, by the DPC/PSC, whichever is earlier.
- b) shall not confer any right of superior claim in favour of the officers for regularization and shall be without prejudice to the outcome of any writ petitions(s) pending consideration before any competent court(s).
- c) shall be reversible without any prior notice to any officers(s) in whose favour any adverse report/remarks are received from any organization/agency.
- d) may not be strictly in order of seniority and will be subject to the final outcome in this regard.


