Under Operation Green's TOP to TOTAL Scheme, sanction is hereby accorded to the;

- a) designation of Director Horticulture (P&M) as Nodal Officer for certification of the eligible farmers/entities who are selling their eligible crops from inside the Mandies in UT of Jammu & Kashmir.
- b) designation of Director Agriculture, Jammu as Nodal Officer for certification of the eligible farmers/entities who are selling and transporting the eligible crops outside the Mandies in Jammu division.
- designation of Director Horticulture, Kashmir as Nodal Officer for certification of claims under the Scheme for the eligible farmers/entities outside the Mandies in Kashmir division.

## Further;

- a) all the Horticulture Development Officers (HDOs) would be responsible for registration of farmers/entities in their respective zones for eligible crops in the eligible districts as per the prescribed formats in Kashmir division.
- b) all the Sub Divisional Agriculture Officers (SDAOs) and Agriculture Extension Officers (AEOs) would be responsible for registering the farmers/entities from the eligible districts for eligible crops in Jammu division.
- c) all the Area Marketing Officers (AMOs) of the respective districts will be responsible for registering the farmers/entities inside the Mandies for all the eligible crops of the eligible districts across J&K.

- d) the complete details as per the prescribed formats along with required documents in each case shall be submitted by the respective Area Marketing Officers (AMOS), Horticulture Development Officers (HDOs), Sub Divisional Agricultural Officer (SDAOs) and Agriculture Extension Officers (AEOs) to the Director Horticulture (P&M), Director Horticulture, Kashmir and Director Agriculture, Jammu respectively on each Friday of the week by 5 p.m.
- e) all the three Nodal Officers (Director Horticulture P&M, Director Horticulture, Kashmir and Director Agriculture) shall further submit the requisite details to National Agricultural Cooperative Marketing Federation of India (NAFED) directly after duly certifying the authenticity of the claims on each Monday by 5 p.m. with a copy to Administrative Department.
