Subject: Tentative Seniority list of Chief Horticulture Officers and equivalent of J&K Horticulture (Gazetted) Service as it stood on 01.01.2017.

Whereas, a combined final seniority list of Gazetted Officers of J&K Horticulture was issued vide Government Order No. 04-Agri of 2010 dated 08-01-2010; and

Whereas, after the issuance of the said seniority list, some officers at the level of CHOs and equivalent have retired after attaining the age of superannuation, some Officers at the level of District Horticulture Officers (DHOs) have been promoted as Chief Horticulture Officers (CHOs) and equivalent vide Government Order No. 62-Agri of 2016 dated 23.02.2016 and while others have been promoted to the next higher grade as Joint Director on the recommendations of PSC/DPC; and

Whereas, all these changes at the level of CHOs and equivalent make it imperative to update their seniority list and also issue a separate seniority list of the officers of the level of CHOs and equivalent; and

Whereas, as a sequel to that all the necessary changes wherever, applicable have been made in the seniority list at the level of CHOs and equivalent, based on the available records of the officers under reference and accordingly a separate tentative seniority list is prepared/framed on the basis of date of confirmation of officers as CHOs and equivalent level; and

Whereas, the seniority of those I/C CHOs and equivalent in whose case recommendation regarding promotion/confirmation has been kept withheld by the PSC/DPC, their rightful position will be incorporated in the seniority list as and when their regularization orders are issued on the recommendations of PSC/DPC.

Now, therefore, a separate tentative seniority list of the CHOs and equivalent as it stood on 01.01.2017 is hereby issued as per Annexure to this Order, for information of all the concerned. The concerned officers have right to represent/ appeal/file objection against the position assigned in the tentative seniority list to the Horticulture Department, Civil Secretariat, Jammu with supporting documents, in case they feel aggrieved, within a period of 21 days from the date of issue of this tentative seniority list, failing which, no objections will be entertained and considered and the tentative seniority list shall be treated as final.

The Date of Birth, recorded in the tentative seniority list shall be subject to further verification with reference to Service records/Matriculation Certificate of the concerned officers.

This issue without prejudice to the outcome of any writ petition on the subject pending before any competent court (s) of law.

The tentative seniority list will also be available on the official website of the Horticulture Department (www.horticulture.jk.gov.in)
