The appointment shall be subject to the following conditions:-

- (i) the appointees shall report to the concerned Directorate of Horticulture, Srinagar/ Directorate of Horticulture, Jammu/ Directorate of Horticulture (Planning & Marketing), J&K as the case may be, within a period of 21 days along with all original certificates. In case any appointee does not join within the said period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.
- (ii) each appointee except those who are already in service, shall give an undertaking in the shape of an affidavit to the effect that:-
  - (a) if on verification the qualification certificate / reserved category certificate / experience certificate (wherever applicable) is found forged, false or fake by concerned issuing authorities, the appointee shall have no claim for appointment.
  - (b) salary of the appointee shall not be drawn and disbursed to him/her unless and until the satisfactory report/genuineness of the certificate in respect of (ii) (a) above is received.
- (iii) The appointee shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:-
  1. Academic /Technical Qualification Certificates.
  2. Matriculation/Date of Birth Certificate.
  3. Health certificate from the concerned Chief Medical Officer of the District .
  4. Domicile Certificate.
  5. Certificate from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self employment scheme has been availed by the appointee.
  6. Relevant Category certificate.
  7. Any other relevant documents, if required;
- (iv) the appointee shall be governed in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S. O. No. 192 of 2020 dated 17.06.2020;
- (v) if by any chance candidate who is not eligible for the post manages to secure selection by way of misrepresentation and false information and it comes to notice at a later stage, he/she will be liable for cancellation of selection and criminal prosecution as well in light of the Judgment rendered by the Hon'ble Supreme Court;
- (vi) the inter-se seniority of the appointees shall be as per the merit as it exists in the selection list prepared by the J&K Services Selection Board;
- (vii) the appointment shall be subject to outcome of the writ petition /OA, if any pending in any competent court/Tribunal;






- (viii) the cadres/departments allocated by appointing authority /SSB shall not be changed under any circumstances by any authority/Department.
- (ix) the appointments shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution;
- (x) The appointment of the above candidates shall be governed by the (New Pension Scheme) as per SRO-400 of 2009 dated 24-12-2009; and
- (xi) the appointee shall furnish an undertaking as per the enclosed format.
